

## Terms & Conditions – Partners in Paediatrics Clinical Guidelines App

### 1. About Us

The App is operated by Partners in Paediatrics (“we”, “our”, “us”). Our website is <https://partnersinpaediatrics.org>.

### 2. Privacy

Your use of the App is subject to our Privacy Policy (<https://partnersinpaediatrics.org/privacy-policy/>). By using the App, you consent to our handling of your personal data in accordance with that policy.

### 3. Eligibility

The App is intended for healthcare professionals and others authorised by Partners in Paediatrics. By registering, you confirm that the information you provide is accurate and that you are eligible to use the App.

### 4. Accounts and Access

- You must create an account to access the App.
- You are responsible for maintaining the confidentiality of your login details and for all activities under your account.
- If you are part of a member organisation, you may access the App free of charge by using a valid membership code provided by your organisation.
- If you leave a member organisation, your access via that organisation will be revoked and you will need to purchase an individual subscription.

### 5. Subscriptions and Payments

- Individual subscriptions are charged on an annual recurring basis at the rate in effect at the time you first subscribe.
- Your subscription will automatically renew each year at the same annual rate unless cancelled.
- Subscription fees are non-refundable, except where required by law.
- You will not be entitled to any subsequent discounts, offers, or promotional rates introduced after you subscribe.

- Payments are processed securely through Stripe, our third-party payment provider. By subscribing, you also agree to be bound by Stripe's Terms of Service (<https://stripe.com/gb/legal>) and Privacy Policy (<https://stripe.com/gb/privacy>).

- You can manage and cancel your subscription directly through your Stripe account.

## **6. Cancellation**

- You may cancel your subscription at any time via your Stripe customer portal.

- If you cancel, your access to the App will end.

## **7. Content and Use**

- The App provides access to clinical guidelines and related materials published by Partners in Paediatrics.

- These materials are provided for professional reference only and are not a substitute for clinical judgement.

- You must use the guidelines responsibly, in line with your professional training, local policies, and clinical judgement.

- You may not copy, distribute, or share content from the App outside your own professional use.
